# WELCOME

We'd like to wish you a warm welcome and extend our thanks for joining our boat members club. We have put this document together for the safety of all members and their guests. These rules apply to your family, guests and pets. Failing to comply with these rules will result in termination of your membership.

As the named boat owner, it is your responsibility to ensure all your friends and guests who come to the lake know the lake's relevant safety issues and etiquette.

Due to the very nature of waterskiing, most lakes or clubs will not employ anyone from dawn till dusk seven days to be available to monitor your skiing when you come to partake in your sport. Cliff Lakes is no different, and there will be many occasions when you are on your own or just with other boat owners.

This manual is intended to answer most of the common questions from our membership about the practicalities of coming to ski here and should mean you can safely go and ski independently, in harmony with other users of the water. It will also point out some etiquette we like to adopt at Cliff Lakes, which help maintain a quality experience for those using the lake.

Please come to the site prepared with everything you need for your session. If you can imagine that you were going to the coast and skiing on the open sea with no services, and come prepared for that level of independence, then any assistance we can offer to you will be a bonus. There is a bar, ski school, cable tow and aqua park on-site, but they may not always be open every time you visit the lake.

## YOUR BOAT

### **Is your boat safe?**

We insist that all boats used on the lake are "safe" and as we cannot take the liability for checking them since we are not qualified marine engineers, we will ask each boat owner to have their boat checked by a qualified person. If your experience in boating is enough for you to feel you could hold yourself out as competent enough and take that responsibility then we will accept your judgment.

What we do require is for you to sign the “Safe Boat and Rules Acceptance Declaration 2021” attached at the back of this manual, and return the completed form to Sue in the office.

The responsibility lies totally with you as the boat owner to be using a safe and well maintained vessel. However if it comes to our attention that a boat is obviously or suspected of being deficient, or of a venerable age then we may ask for an independent marine engineers report the cost to be borne by the boat owner.

## **LPG**

LPG is a highly flammable fuel, please exercise caution when refueling your boat, and run the bilge blower according to manufacturer’s instructions prior to starting the engine. LPG conversion should be carried out professionally and in accordance with approved British Standards and other recommendations and maintained in accordance with manufacturers recommendations.

## **Storage**

Boats are stored on trailers on the southern shore to the west of the clubhouse. New parking bays have been created and numbered. Please use the numbered bay allocated to you. We do expect you to keep the area around your boat tidy and free of litter; for example, old 5-gallon tanks, covers, prop bags, two-stroke oil bottles, car batteries, lighting boards should be removed.

Empty trailers from boats on dock lifts should be stored with suitable security, i.e. wheel clamp or hitch lock, and may, with permission from Richard, be stored in the caravan compound.

## **A Boat Owner may store one boat.**

We want to try and minimize the about of stuff stored at Cliff Lakes to help us keep the site tidy. If you choose to keep a 4x4 on-site, please do not park where the bays are. Please store in the parking area beyond the containers of the premier lake. Please park economically, using up minimal space.

There is a new club 4x4 on site which can be used for a small annual cost of £60. Please speak to Richard Quill to use this.

## **Launching**

The slipway is situated on the other side of the clubhouse. The etiquette is that boats launching have priority and that You should clear the slipway and approach straight away, so you do not block it for another user. Since the slipway is right outside the bar, we ask that you clean boats, prepare them for trailing etc., in your parking space.

Please take care as slipways can be slippery. It would be best to wear a wetsuit and investigate the slipway thoroughly before using it for the first time, so you can see where the ramps end and the best line for launching.

NO BOATS should be left moored on the water overnight unless you have rented a floating mooring space for the season. Boats can wait or be temporarily moored on the large blue landing stage in front of the slipway. But again, only over a short period.

### **Trailers**

Once launched, you should move your car and trailer well out of the way of the slipways and not block any other boat bays or traffic.

Please remember some trailers and vehicles have large turning circle requirements, so nothing should be left at all in the vicinity of the slipway.

### **Insurance**

Due to the FSA, we cannot insist on who you insure with. However, we do ask that you certify to us that your boat is fully insured with £2M at least of 3rd party liability. The "Safe Boat and Rules Acceptance Declaration" covers this point. R.A. Carter can provide advice and cover if you require.

We do not check or chase insurances and make no warranty to other members that each boat is insured. We will just confirm that it is a condition of membership to have the boat insured at all times in the season.

### **Boat Drivers**

All drivers must be SBDA qualified and up to date, which means a current member of the British Water Ski and Wakeboard. We will collect your membership fees at the start of the season, and the new rates are set annually by British Water Ski and Wakeboard. Additional memberships can be bought. Please contact Sue in the Boat Owners Office for further details. Membership benefits can be viewed at [www.bws.org.uk](http://www.bws.org.uk).

The SBDA can be taken at the club by calling The Principal (contact details available on the website), who will arrange times and dates to suit all, as prices can vary as it is dependant upon the number of candidates and their relevant experience, and the boat that they use.



You will be asked to provide details of your boat drivers on the booking system in advance of the season and confirm they are SBDA qualified. Boat drivers can also renew their British Water Ski and Wakeboard membership through us.

Drivers who are in training can drive if a qualified SBDA holder is in the boat with them. In training is defined as having a date booked with The Principal to take the SBDA test.

Please note it is a condition of membership and a key element of your membership that:

It is the contractual responsibility of the named boat owner to ensure the boat is being driven safely at all times by qualified people who are properly insured.

There shall be a minimum of two people in the boat when towing a skier, i.e. a responsible adult as an observer unless the driver is a qualified BWS instructor (and can show the relevant documentation) and only one boat is in use on the lake.

## THE LAKE

The rules (enclosed) cover the operation of boats on the water. Still, we want to stress a few key points, following an accident many years ago, which was beyond question the driver and skier's fault. As a result, this has led to the ambulance-chasing lawyers having a pop and costing us all time and effort in defending a case where a large number of our customers witnessed driver stupidity.

It is your responsibility to ski and drive safely; boat owners use the lake and facilities entirely at their own risk. This includes familiarizing yourself with the lake, considering any changes that have happened, provision of bunds, jetty position, level of water, other users and their relevant experience, and anything else that could affect your safety.

You must check to your satisfaction that it is safe to ski on each occasion. We make no warranty as to the lake's safety, only that it is suitable for waterskiing if one adheres to all the rules, safe practices, common sense and checks relevant conditions on each occasion.

The BWSF Code of Practice for Safe Driving is available to download from our website. It is a rule of membership that all drivers and skiers familiarize themselves with this document.

## Critical reminders for drivers and skiers

- If in doubt, STOP.
- Don't drive/ski close to any fixed object or shoreline; you can always slow down or stop if in doubt. Ensure your speed and course on returning to the jetty facilitate a safe finish by your skier. You can still stop short if in doubt. Safe landings are the drivers and skiers responsibility.
- Don't let the skier build up uncontrollable speed in the turns.
- Be aware of the position of any other craft on the water.
- Be sure of the correct lines to drive and the circuit to drive.
- We drive a clockwise circuit, so the local rule of two boats approaching head-on turn is turn to port. This overrides the standard maritime practice and safe code of conduct.
- Boats are NOT PERMITTED ON THE WATER AFTER DUSK/DURING THE HOURS OF DARKNESS. If you are booked on the lake for the final slot and darkness falls, please stop skiing and retrieve your boat immediately.
- Children and minors are your responsibility and should never be left unattended or allowed to wander the site without competent adult supervision.
- The Drinking Water Directorate's Guidelines for anyone involved in water sports on inland waters should be adhered to; be aware of the water quality, for example, following a flood. The lake is not a swimming pool, and you ski at your own risk.
- No unnecessary swimming in the lake.
- Avoid ingestion/swallowing the water.
- Do not allow cuts or wounds to come into contact with the water, i.e. cover with a waterproof dressing.
- Some sore throats may result from ingestion of the water. These should only last for a couple of days, if at all! Please consult your doctor if any other symptoms, including sickness and tummy upsets, don't respond to treatment, please consult your doctor.
- Consult a doctor for any flu-like symptoms.
- Please be aware Leptospirosis or Weil's disease is at all times a possibility. As you know, it is a disease carried in rat urine. This is not a significant risk, particularly after flooding [rats don't swim so well]. Some water ski clubs issue regular bulletins about this.
- All these precautions should already be undertaken by people at the lake, as general good practice. Inadequate or unsafe driving witnessed.

Please remember we do not operate any form of monitoring or policing service, so if you witness poor or unsafe driving and feel it dangerous to use your boat, the following courses of action are open to you.

Address it politely with the driver directly. You may well find yourself sharing water time with them in the future, so why not try and ensure you can ski safely together. Please fill in an incident report (copy attached and also available on the internet).

We will then take the matter up with the member and any other witness. We will not discuss any issues with another driver without an incident report.

## **Courtesy and Etiquette**

Please try to drive and ski considerately by;

- Not spraying the crowd when you finish your run
- Not doing tight turns with a ringo/doughnut when other riders are using the lake.
- Not power turning when a skier or rider has fallen.
- Instead, slow down and return to your rider calmly. Think straight lines, precise driving, and safety! Please note, wakeboard boats, ringos, and inflatables are not allowed on the premier lake.

## **Aqua Park**

The Aqua Park will be clearly outlined; it is strictly prohibited for any boat or skier/wakeboarder to enter this protected area at any time.

## **Paddle Board Arena**

Boats launched from the main slipway need to make their way around the paddleboard arena, which will be clearly marked with red/white baton buoys heading towards the premier lake at trickle speed then across the ski school landing stage into the main lake channel that will be marked.

## **Open Water Swimming**

Boat drivers gaining access to or from the gas dock, slipway, boat lifts or lakes should proceed with caution at trickle speed and await an indication from a staff member that it is safe to cross the swimming area. When launching or recovering on the slipway, please use the landing stages as a parking spot whilst waiting for your trailer etc.

## **Injuries**

Please note, no supervision or provision of first aid is offered at the site. It is a rule that all boats carry first aid equipment, and the boat owner is directly responsible for looking after their skiers and guests' welfare.

Should you or any of your guests incur an injury, an accident report form must be completed by the boat owner immediately or as soon as is practically possible afterwards, and posted to the office. Copies are available on the internet or in the Boat Owners manual.

# BOOKING SYSTEM

To access the booking system, please head to [member.cliffflakes.co.uk/](https://member.cliffflakes.co.uk/)

Upon joining the club, you will be issued with a boat number/user name and password.

All boats must display their boat number on the windscreen and trailer at all times. You will be issued 2 small boat stickers that you will need to write your boat number and the current year (2021). You can collect this from the office along with your Aqua Park vouchers.

Please ensure that you have booked your boat onto the water before you launch your boat.

A boat may only pre-book one 3 hour slot on any day at the weekend, if at the end of that slot the next slot is still available, it is permissible to book onto it. Only the boat that is booked in on the booking system may use that slot, unless exceptional circumstances and the boat owners is given prior permission by Emma Quill, Richard Quill or Sue Barnett. If any boat owner has booked more than one slot on any day then the management will cancel additional bookings without consultation.

## AQUA PARK

The Aqua Park can only be used during a public session, and a booking has been made via our online booking system.

At the start of the season, you will be issued complimentary Aqua Park vouchers, which can be used throughout the season on our public Aqua Park sessions. You may use the vouchers as you wish. To redeem these complimentary tickets, head to our website, book a session, and enter the code into the gift voucher box at checkout, and complete your disclaimers before arriving.



# SITE BARRIERS

At the start of the season each member will be assigned 2 barrier pass and will be able to add their car to the ANPR system. The site barriers are there to secure our site. We are continually improving and developing the site. If you have any questions regarding the barriers, then please speak to Richard Quill.

# FACILITIES

## **Caravans**

Boat owners may purchase a membership with caravan pitch if required. A caravan pitch is only allocated to a boat owner for the season on request.

## **Toilets**

The toilets are located outside of the clubhouse and are available to our guests during the day. The toilets will be locked at 20:00, and members may use the passcode to gain access. While the toilets are out of hours, we ask that you lock these after use to prevent members of the public from gaining access to them. We ask that no chemicals or caravan waste is to be disposed of in these toilets.

## **LPG**

LPG is for sale on site subject to price change with market fluctuations.

## **Club 4x4**

A new club 4x4 has been purchased (Nissan Navara ), which is available for use by members. It will cost £60 for the season, which will go towards the fuel and upkeep of the vehicle etc.

# MEMBERS BEACH

This area is for the use of boat owners, caravan members, and their guests only. The area can only be gained access to a coded gate at the top of the steps. There is no access through or around the Aqua Village area.

## Rules

- The members beach should not be used after dusk.
- All dogs are the owner's responsibility.
- There will be a BBQ (gas) supplied in this area. The BBQ should be left clean after use, ready for the next user.
- The beach area will be occasionally checked by management, but we expect members to each hold responsibility for this area. This includes keeping it tidy, ensuring furniture is returned to how it was found.
- Children playing in this area must not swim out beyond the end of the boat lifts when boats are on the water.
- All children playing in the water should be wearing life jackets/ impact vests.
- An adult must supervise children under the age of 16 at all times.

## Rules

This contract of membership is with KINGSBURY WATERSPORTS LTD and all cheques and fees are payable to it.

### Your Boat

Your boat must be adequately insured at all times it is in use or on site.

Your boat must be safe and you will sign to say it has been checked by a competent person.

### Fees and Payments

A membership runs from January 1st each year.

Unspent ski credits shall not be carried over to the next season if a membership is renewed.

Ski credits are not transferable to other members.

The membership licences ONE boat only, groups with more than one boat, will need a membership for each vessel. Where groups have formed to split the costs of the sessions, we will not accept individual cheques, it will be up to the boat owner to collect the funds, and they are responsible for making the correct payment, on behalf of their group.

### Bookings

A booking is specific to a lake and boat. ONLY you can only ski on the lake you have booked with the boat that is booked on.

### Circuit Operation

Only three boats shall use the boat owners lake at any time, and only one boat on the premier lake for 10 minutes or six passes of the slalom course.

### Use of the Lake and Facilities

- All drivers shall be SBDA qualified or under instruction. Under instruction is defined as having a qualified SBDA holder as a crew, and also having booked to take the SBDA at a defined future date. An SBDA is only valid if membership is current of the BWS.
- Ringos, inflatables and wakeboard boats are not allowed on the premier lake.
- The boat owner must provide us with a list of their qualified drivers, please fill in this information in the 'account profile' page on the booking system.
- The boat registration number provided must be stuck on the hull, clearly visible and
- If in doubt in any situation whatsoever - STOP.
- The slalom course must never be used if there is a buoy missing, please fix it and fill in the log sheet.
- A skier in the water must not be taken aboard without first turning off the engine.
- Ropes should be pulled in immediately a skier has fallen except when there are no other boats on the circuit, or in the vicinity.
- Once a skier has dropped off the boat should then proceed out of the path of vessels looking to commence skiing and retrieve the line.
- Boats returning a skier have priority over those starting off.
- Skiers should use and learn the BWSF approved signals.
- An arm shall be raised by the driver or crew when dropping a skier off to alert those waiting to set off as to their intentions.
- We recommend appropriate safety wear, namely helmet and impact jacket / vest when using the jump or slider.



- No finned boards or skis shall be used on the jump.
- No one shall use the lake under the influence of drugs or alcohol.
- Boat drivers shall not allow passengers to sit or ride on the boats deck or sides or bow whilst the boat is in motion.
- Those boats launching shall have priority over those retrieving. There is no supervision provided, so you will use the lake totally at your own risk. At the end of your session you must vacate the dock.
- Please show consideration for other ski boats, particularly if you are towing an inflatable.
- Upon hearing one long blast of a horn all boats shall return immediately to the jetty.
- Boat drivers shall keep as far away as possible from any wildlife.
- There shall be a minimum of two people in the boat when towing a skier, ie a responsible adult as an observer, unless the driver is a qualified BWS instructor (and can show the relevant documentation) and only one boat is in use on the lake.
- Boats are NOT PERMITTED ON THE WATER AFTER DUSK/DURING THE HOURS OF DARKNESS. If you are booked on the lake for the final slot and darkness falls, please stop skiing and retrieve your boat immediately.
- All members and their guests use the lake and facilities at their own risk. A member who invites guests must inform them of these rules. If the guest does not agree, then they are not allowed on the site.
- Cars and vessels using the slip way shall do so at their own risk.
- We reserve the right to ban or revoke a membership of any person and ask them to leave the site without explanation.
- Any person banned shall not be entitled to any refunds.
- Bookings shall not be used for commercial activities, i.e. private ski lessons.
- It is the responsibility of the person who has made a booking to inform his or her party of all rules and regulations. The member is also responsible for the safe operation and driving of their boat, regardless of whether they are actually driving it or not.
- If you inadvertently damage or break anything on the site, you are responsible for the cost of repair or replacement in full.
- KINGSBURY WATERSPORTS LTD reserves the right to close the lake for any period of time when reasonable notice shall be given, except in the event of an act of God or Nature, when the lake shall be closed at our discretion. No refunds are payable regardless of the reason or length of closure.
- KINGSBURY WATERSPORTS LTD can cancel any pre-reserved slots for the purpose of holding a competition.
- KINGSBURY WATERSPORTS LTD, its management or staff cannot be held responsible for the theft, loss, damage of any property, valuables or equipment on the premises.
- All items are left at the owners risk.
- All visiting dogs to be kept on a lead or under control and their mess cleared.

#### **General**

- KINGSBURY WATERSPORTS LTD shall not be responsible for injury or liable for any event resulting from the members use of the facilities, howsoever caused.
- KINGSBURY WATERSPORTS LTD makes no warranties as to the safety of these rules or the lake and accepts no liability whatsoever for any accident or injury or any other claim on us arising from your use of the lake and land and facilities.
- KINGSBURY WATERSPORTS LTD reserves the right to add, omit, change or alter any rule, rules or booking times at any time without notice.



- The right of interpretation as to the meaning of these rules is vested in KINGSBURY WATERSPORTS LTD Its decision shall be final and binding.
- These rules and regulations have been complied for your maximum enjoyment.
- If there is anything you do not understand or have difficulty in interpreting, please do not hesitate to ask.
